We would like to inform the stock exchange about the intimation received from M/s. Dharani Credit and Finance Private Limited (Promoter Group) about the acquisition of 22,021 (0.44%) equity shares of the Company in the open market and the same is being attached.

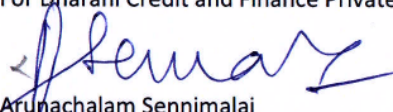
